4. FIRST-AID MEASURES:

7. HANDLING and STORAGE:

Handling:

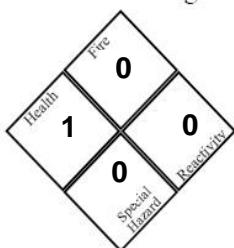
