### 4. FIRST-AID MEASURES:

### 5. FIRE-FIGHTING MEASURES:

### 7. HANDLING and STORAGE:

**Handling:**

**General advice** - No specific measures are necessary provided product and recommended protective clothing/equipment are used correctly. Do not mix with other chemicals. This is a commercial product, not intended for home use. Keep out of reach of children.

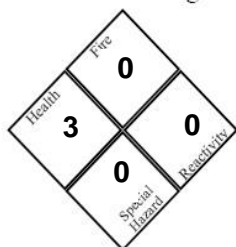
