4. FIRST-AID MEASURES:

Personal precautions:

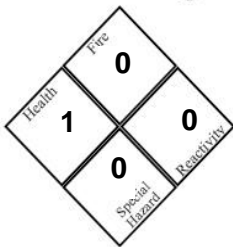
