### 4. FIRST-AID MEASURES:

### 7. HANDLING and STORAGE:

**Handling:**

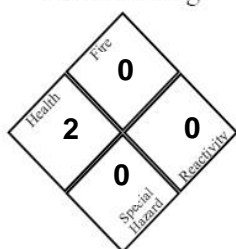
