## **GLASS RESTORATION TREATMENT**

### **HEAVY DUTY WINDOW SCALE REMOVER**

**DESCRIPTION:** GLASS RESTORATION TREATMENT is an organic acid based glass restoration cleaner designed to easily remove hard water scale and salt spray buildup from windows. GLASS RESTORATION TREATMENT can be used in combination with SURTEC GLASS RENEW for removal of heavy scale buildup.

#### **DIRECTIONS:**

##### **Removal of Minor Scale:**

Using a trigger sprayer and a 1:1 solution of GLASS RESTORATION TREATMENT spray the dilute solution directly to the glass and scrub using a mild abrasive pad. This procedure should remove the minor buildup of the calcium scale. Repeat as necessary to fully remove scale buildup. Squeegee the solution from the window surface and spray the window with SURTEC 909 GLASS & PLEXIGLAS CLEANER and wipe clean and dry with a microfiber cloth.

##### **Removal of heavy scale buildup from glass surfaces with GLASS RESTORATION TREATMENT and GLASS RENEW combination:**

Pre-spray the glass surface with GLASS RESTORATION TREATMENT diluted 1:1 with water, then also spray the solution onto a mild abrasive pad. Sprinkle SURTEC GLASS RENEW powder onto the pad. Scrub the glass surface with pad until the residue is removed. After cleaning the surface, squeegee the window and check for results. Repeat as necessary to fully remove scale buildup. When the cleaning solution has been completely removed from the surface, spray the surface with SURTEC 909 GLASS & PLEXIGLAS CLEANER and wipe dry with a microfiber cloth.
